Vitamin liquid formula

Paravit®-Mod liquid is a Food for Special Medical Purposes. For the dietary management of patients with cystic fibrosis on the specific recommendation of a cystic fibrosis specialist. Paravit®-Mod contains higher amounts of fat soluble vitamins than regular food supplements.

Important information: Paravit®-Mod may not be used as a sole source of nutrition and is not a substitute for a varied diet. Paravit®-Mod has been designed specifically for patients with cystic fibrosis and should be only used by this group. This product poses a health hazard if consumed by persons who do not have the medical condition for which the product is intended. Paravit®-Mod may only be used during pregnancy if advised by a doctor.

How to use and store Paravit®-Mod

For oral use only. To be taken with a meal. Speak with your cystic fibrosis dietitian on how to take Paravit®-Mod. Store in a cool, dry place, below 25°C. Do not freeze. Keep away from children. Do not use if the seal on the bottle is broken before starting to use Paravit®-Mod. After use, close the bottle with the cap, store in refrigerator and consume within 60 days. Paravit®-Mod comes with a measuring device. When preparing Paravit®-Mod for use, open the bottle containing Paravit®-Mod liquid, by breaking the seal. Push the measuring device firmly into the plastic stopper in the neck of the bottle.

To fill the measuring device, turn the bottle upside down. Whilst holding the measuring device in place, gently pull the plunger down drawing the liquid to the correct dose on the measuring device. Turn the bottle the right way up, and holding the bottle, gently twist and remove the measuring device from the bottle plug. Place the tip of the measuring device into the mouth and depress the plunger to administer the dose. Replace the lid on the bottle and wash the measuring device out using hot water. Place the bottle and measuring device back into the outer carton.

How much Paravit®-Mod should be taken

The recommended starting dosage of Paravit®-Mod follows guidance of the Cystic Fibrosis Trust 2016 and ESPEN-ESPGHAN-ECFS guidelines on nutrition care for infants, children, and adults with cystic fibrosis 2016 and is as follows:-

Infants 0 to 12 months of age: 0.1ml per day measured by a supplied measuring device. Discard any unused liquid after 60 days. Special care should be taken to avoid overdosing in this age group by using the measuring device supplied.

Children 1 to 8 years of age: 0.25 ml per day.

Over 8 years of age (including adults): 0.5 ml per day.

The recommended daily doses are higher than a normal food supplement. This is because they take into account the suboptimal absorption capability of patients with Cystic Fibrosis.

Do not exceed the stated daily dose.

7ml of the liquid formula will provide sufficient volume for 14 days treatment for an adult (or child over 8 years of age) and 28 days treatment for children and infants (Up to 8 years of age). To ensure that the measuring device can extract 7ml of liquid during the full treatment period, there is an additional 1ml of liquid in the bottle (making a total content of 8ml). At the end of your treatment period, some liquid will remain in the bottle which should then be discarded.

Ingredients:

Vitamin E (DL- α -tocopheryl acetate); Medium Chain Triglycerides (**coconut and palm oil origin**);

Vitamin K1 (phytomenadione); Vitamin A (retinyl palmitate); Vitamin D3 (cholecalciferol).
